Application Checklist:

- Apply and be admitted to CMU/CMU Tech as a Pre-Aviation major.
- Obtain an FAA Medical Certificate
 - 1st Class is recommended but not required.
 - If your medical is deferred, please contact the Director of Aviation.
- Fill out Aviation Technology New Student Application form.
- Using your CMU email address, submit the following documents, in one email, to mgraham2@coloradomesa.edu. Documents not in PDF form will not be accepted.
 - PDF of short essay responses.
 - PDF copies of required identification documents
 - Valid U.S. passport
-- OR --
 - Valid Driver License and Birth Certificate
 - Non-US citizens should submit valid photo ID and valid passport.
 - Once accepted into the program the Transportation Security Administration (TSA) will require further documentation and background check. Students who are not cleared by the TSA will be dismissed from the program.
 - PDF copy of valid FAA medical certificate.
 - PDF of completed Aviation Technology New Student Application form.

If wanting to join in Spring as an instrument student also include:

- Copy of your private pilot certificate
-- OR --
- Evidence that the private pilot certificate will be obtained prior to January 1st.
 - Letter from current CFI, and
 - Copy of logbook or flight training record
- Received confirmation email stating that you have completed the application process.
 - Applications will be considered complete when all requirements have been submitted, together, in one email AND the applicant has received an email stating that their application is complete.
 - Applications will be accepted between Nov 1st and Jan 31st.
 - Applications are due November 30th for the following Spring Semester for students wanting to join Instrument Pilot. Students must have their Private Pilot Certificate prior to January 1st to join Instrument in the spring.
 - Applicants will be notified of CMU Tech's decision in February via the applicants CMU email address. All other correspondence will be through this email address.

Note: Applications that are found fraudulent, plagiarized (including use of AI), or incomplete will not be considered.
